RESOLUTION OF THE BOARD OF SUPERVISORS OF THE  
COUNTY OF VENTURA ORDERING, WITHOUT ELECTION,  
THE WOOD RANCH REORGANIZATION, i.e., ANNEXATION  
TO THE CONEJO RECREATION AND PARK DISTRICT, DE-  
TACHMENT FROM THE RANCHO SIMI RECREATION AND  
PARK DISTRICT AND DETACHMENT FROM THE SIMI VALLEY  
PUBLIC CEMETERY DISTRICT

WHEREAS, the Board of Supervisors of the County of Ventura  
on November 8, 1983, initiated proceedings to reorganize the  
boundaries of the Conejo Recreation and Park, Rancho Simi  
Recreation and Park and Simi Valley Public Cemetery Districts;  
and

WHEREAS, the Local Agency Formation Commission (LAFCO), on  
January 11, 1984, found the territory to be uninhabited and  
approved the reorganization and assigned the following short  
title to the proceeding:

WOOD RANCH REORGANIZATION: ANNEXATION TO THE  
CONEJO RECREATION AND PARK DISTRICT/DETACHMENT  
FROM THE RANCHO SIMI RECREATION AND PARK DIS-  
TRICT/DETACHMENT FROM THE SIMI VALLEY PUBLIC  
CEMETERY DISTRICT

WHEREAS, the proposal has been reviewed and found to be  
categorically exempt from the California Environmental Quality  
Act; and

WHEREAS, the Board of Supervisors finds the reorganization  
to be in the best interests of the landowners within the reor-  
ganization area and the total organization of local governmental  
agencies within Ventura County.

NOW, THEREFORE, BE IT RESOLVED, DETERMINED AND ORDERED as  
follows:

- (1) Said reorganization is hereby ordered without election.

(2) The boundaries of the reorganization are found to be definite and certain as approved and set forth in Exhibit A, attached hereto and made a part hereof.

(3) The territory shall be liable for existing bonded indebtedness of the annexing agency.
