### NOTICE OF PUBLIC HEARING

**NOTICE IS HEREBY GIVEN** that a Public Hearing will be held by the Ventura Local Agency Formation Commission (LAFCo) for the following matter:

#### **LAFCo 15-11(S1-S2) City of San Buenaventura Sphere of Influence Amendments**

**Project Description:** The project includes the following requested sphere of influence amendments, to allow for an annexation to the City of San Buenaventura which would enable the extension of Olivas Park Drive and the construction of a levee along the Santa Clara River:

- Amendment to the sphere of influence of the City of San Buenaventura [LAFCo 15-11(S1)] to include a 6.65-acre site (known as Assessor's Parcel Number 179-0-050-030).
- Amendment to the sphere of influence of the Montalvo Community Services District [LAFCo 15-11(S2)] to remove the 6.65-acre site.

The project also includes the following (LAFCo 15-11 City of San Buenaventura Reorganization – Olivas Park Drive Extension):

- Annexation of the 6.65-acre site to the City of San Buenaventura and the Ventura Port District.
- Detachment of the 6.65-acre site from the Ventura County Resource Conservation District, Ventura County Fire Protection District, Ventura County Service Area No. 32, and Ventura County Service Area No. 33.

**Purpose of the Public Hearing:** All interested persons are invited to attend, be heard, and participate in the hearing. At the Public Hearing, LAFCo will consider all written and oral comments that have been submitted regarding the matter and will review and approve (with or without amendments, wholly, partially, or conditionally), disapprove, or continue the proposal.
