NOTICE OF PUBLIC HEARING

NOTICE IS HEREBY GIVEN that a Public Hearing will be held by the Ventura Local Agency Formation Commission (LAFCo) for the following matter:

LAFCo 18-07 and 18-07 (S1-S5) City of Oxnard Reorganization and Sphere of Influence Amendments – Ocean View School District

Project Description: The project includes the following requested sphere of influence amendments, to allow for an annexation to the City of Oxnard that reflects existing City water service:

- Expansion of the spheres of influence of the City of Oxnard, Calleguas Municipal Water District, and Oxnard Harbor District to accommodate the annexation of an approximately 5-acre property (owned and operated by the Ocean View School District) and contiguous roadway to the City
- Reduction of the spheres of influence of Oxnard Drainage District No. 2 and Ventura County Service Area No. 33 to reflect the annexation of territory into the City

The request is associated with a reorganization proposal (LAFCo 18-07), which includes: annexation of territory to the City of Oxnard, Calleguas Municipal Water District, and Oxnard Harbor District; and detachment from Oxnard Drainage District No. 2, Ventura County Service Area Nos. 32 and 33, the Ventura County Fire Protection District, and Ventura County Resource Conservation District.

Purpose of the Public Hearing: All interested persons are invited to attend, be heard, and participate in the hearing. At the Public Hearing, LAFCo will consider all written and oral comments that have been submitted regarding the matter and will review and approve (with or without amendments, wholly, partially, or conditionally), disapprove, or continue the proposal.
