**NOTICE IS HEREBY GIVEN** that the following matters will be heard by the Ventura Local Agency Formation Commission (LAFCo) at public hearings and that all interested persons are invited to be present and heard:

**Review and/or update of the sphere of influence boundaries for the following cities:**

**City of Camarillo, City of Fillmore, City of Moorpark, City of Ojai, City of Oxnard, City of Port Hueneme, City of San Buenaventura, City of Santa Paula, City of Simi Valley, and the City of Thousand Oaks**

### **Purpose of the Public Hearings:**

Pursuant to Government Code § 56425(g), the Commission must, as necessary, but not less frequently than every five years, review and update the sphere of influence of each city and special district. A sphere of influence is defined in Government Code § 56076 as the probable physical boundary and service area of a local agency. At the public hearings, LAFCo will consider written and oral comments that have been submitted regarding the subject matters, and actions may be taken with respect to the review and/or update of the sphere of influence boundaries for each of the subject cities.
