**NOTICE IS HEREBY GIVEN** that a Public Hearing will be held by the Ventura Local Agency Formation Commission (LAFCo) for the following matter:

LAFCo 21-11 and LAFCo 21-11S Pleasant Valley Recreation and Park District Annexation and Sphere of Influence Amendment – Somis Ranch

This matter was originally scheduled for LAFCo consideration on November 17, 2021, but was continued to December 15, 2021.

## **Project Description:**

The project includes a sphere of influence amendment to the Pleasant Valley Recreation and Park District (PVRPD) to allow for annexation to the PVRPD in anticipation of development of 360 dwelling units. The project site consists of Assessor's Parcel Number 156-0-180-48 (portion), located at 2789 Somis Road, approximately 650 feet north of the intersection of Las Posas Road/Upland Road and Lewis Road/Somis Road, immediately northeast of the City of Camarillo.
