NOTICE OF CONTINUED PUBLIC HEARING

NOTICE IS HEREBY GIVEN that a Public Hearing will be held by the Ventura Local Agency Formation Commission (LAFCo) for the following matter:

Review and/or update of the sphere of influence boundary for the Camarillo Healthcare District

This matter was originally scheduled for LAFCo consideration on November 17, 2021, but was continued to December 15, 2021. While this notice for the December 15, 2021, continued hearing is not required, it is being provided as a courtesy.

Purpose of the Public Hearing: All interested persons are invited to attend, be heard, and participate in the Public Hearing. Pursuant to Government Code § 56425(g), the Commission must, as necessary, but not less frequently than every five years, review and update the sphere of influence of each city and special district. A sphere of influence is defined in Government Code § 56076 as the probable physical boundary and service area of a local agency. At the Public Hearing, LAFCo will consider all written and oral comments that have been submitted regarding the matter, and actions may be taken with respect to the review and/or update of the sphere of influence boundary for the district.
