**NOTICE IS HEREBY GIVEN** that the following matter will be heard by the Ventura Local Agency Formation Commission (LAFCo) and that all interested persons are invited to be present and heard:

**LAFCo 17-05 Camarillo Sanitary District - Camarillo Airport:** The request is for an extraterritorial service agreement (known as an Out of Agency Service Agreement, or OASA) for sewer service from the Camarillo Sanitary District, to be provided outside the District's jurisdictional boundaries to allow for the construction of new aircraft hangars within an approximately 20-acre area at the northeast corner of the Camarillo Airport (portions of Assessor's Parcel Numbers 230-0-030-22 and -24).
