



Ventura County Special Districts

Bardsdale Cemetery District	Operates a cemetery in the Fillmore/Bardsdale area.
Bell Canyon Community Services District	Contracts for extra traffic patrol, trash collection and paramedic services for the unincorporated community of Bell Canyon.
Blanchard/Santa Paula Library District	Provides library services within the City of Santa Paula and vicinity.
Calleguas Municipal Water District	Provides wholesale water from the State Water Project to cities and other districts for much of the area south of the Santa Clara River.
Camarillo Health Care District	Provides various extra health care services and related transportation services to most of the City of Camarillo and the CSUCI area.
Camarillo Sanitary District	Provides sanitary sewer collection and treatment services to the City of Camarillo and vicinity, generally west of Lewis Road.
Camrosa Water District	Provides retail water, sanitary sewer collection and treatment services to the eastern part of the City of Camarillo, the Tierra Rejada and Santa Rosa Valleys and CSUCI.
Casitas Municipal Water District	Provides wholesale and retail water services to most of the Ojai Valley, Ventura River Valley, and the western part of the City of Ventura. Provides recreation services at Lake Casitas.
Channel Islands Beach Community Services District	Via contract, provides retail water, sanitary sewer collection and treatment, and trash collection services to the unincorporated communities of Hollywood by the Sea and Silver Strand Beach.
Conejo Recreation & Park District	Provides recreation and park services to the City of Thousand Oaks and vicinity.
El Rancho Simi Cemetery District	Operates a public cemetery in the City of Simi Valley and vicinity.
Fillmore-Piru Memorial District	Operates the Veterans Memorial Hall in Fillmore.
Fox Canyon Groundwater Management Agency	Monitors the quality and regulates the quantity of groundwater in the Fox Canyon aquifer (Oxnard Plain area from the City of Fillmore to the Pacific Ocean). Does not provide direct water service.
Gold Coast Transit District	Provides transit services in the Cities of Ojai, Oxnard, Port Hueneme, and Ventura, and in the unincorporated County.
Hidden Valley Municipal Water District	Monitors water demand and supplies for 37 ranches in the Hidden Valley area south of Westlake Village. Does not provide any direct water service.

Ventura County Special Districts

Lake Sherwood Community Services District	Provides no services as of July 1, 2015. Formerly provided retail water to the unincorporated Lake Sherwood community.
Meiners Oaks Water District	Provides potable water service via wells to the unincorporated community of Meiners Oaks.
Montalvo Community Services District	Provides sanitary sewer collection and treatment services to the Montalvo area within the City of Ventura.
Ojai Basin Groundwater Management Agency	Provides groundwater management through well regulation to the entire Ojai Valley east of Highway 33. Does not provide direct water service.
Ojai Valley Sanitary District	Provides sanitary sewer collection and treatment services in the Ojai Valley and Ventura River Valley north of the City of Ventura.
Ojai Water Conservation District	Monitors groundwater recharge for the Ojai Valley east of the City of Ojai. Does not provide direct water service.
Oxnard Drainage District No. 1	Operates surface and subsurface agricultural drainage systems west of the City of Oxnard.
Oxnard Drainage District No. 2	Operates surface and subsurface agricultural drainage systems east of the City of Oxnard.
Oxnard Harbor District	Owns and operates the Port of Hueneme.
Piru Public Cemetery District	Operates a public cemetery in the Piru area.
Pleasant Valley County Water District	Provides irrigation water to a 12,000 acre area south of the City of Camarillo on both sides of Las Posas Road between US 101 and US 1.
Pleasant Valley Recreation and Park District	Provides recreation and park services to the City of Camarillo and vicinity.
Rancho Simi Recreation and Park District	Provides recreation and park services to the City of Simi Valley and vicinity.
Saticoy Sanitary District	Provides sanitary sewer collection and treatment services to the unincorporated community of Saticoy.
Triunfo Sanitation District	Provides sanitary sewer collection, and via contract, treatment service to the Oak Park, Lake Sherwood, and Bell Canyon areas, and the Westlake Village area of the City of Thousand Oaks. Provides potable water service to the Oak Park area.
United Water Conservation District	Provides surface and groundwater conservation, groundwater replenishment, and wholesale water for ag. and urban uses in the Santa Clara River Valley and the Oxnard Plain area. Provides potable water and recreation services at Lake Piru.
Ventura County Fire Protection District	Provides fire protection and paramedic services for all unincorporated areas in the County and for all cities except Fillmore, Oxnard, Santa Paula and Ventura.

Ventura County Special Districts

Ventura County Resource Conservation District	Develops plans for soil and water conservation including erosion control for all unincorporated areas in the County.
Ventura County Service Area No. 3	Provides private road maintenance for Camp Chafee Road in the unincorporated community of Casitas Springs.
Ventura County Service Area No. 4	Provides street lighting, street sweeping, landscape maintenance, school crossing guard and transportation services for the unincorporated community of Oak Park.
Ventura County Service Area No. 14	Provides street lighting and street sweeping services to developed unincorporated areas countywide.
Ventura County Service Area No. 29	Provides sanitary sewer collection and, via contract, treatment services to the unincorporated communities of Mussel Shoals, Seacliff, Faria and Solimar Beach.
Ventura County Service Area No. 30	Provides sanitary sewer collection and, via contract, treatment services to the community of Nyeland Acres.
Ventura County Service Area No. 32	Monitors and regulates individual sewage disposal systems in all areas outside cities and sanitation/sanitary districts.
Ventura County Service Area No. 33	Provides park and recreation services in all areas outside cities and park and recreation districts.
Ventura County Service Area No. 34	Operates and maintains a sanitary sewer collection system, and via contract, treatment services for the unincorporated communities of El Rio and Strickland Acres.
Ventura County Watershed Protection District	Establishes and regulates flood protection facilities and floodways along streams and rivers countywide.
Ventura County Waterworks District No. 1	Provides potable, retail water and sanitary sewer collection and treatment services to the City of Moorpark and areas to the north and west of the City.
Ventura County Waterworks District No. 8	Provides potable retail water service to the City of Simi Valley and vicinity.
Ventura County Waterworks District No. 16	Provides potable, retail water and sanitary sewer collection and treatment services to the unincorporated community of Piru.
Ventura County Waterworks District No. 17	Provides potable retail water service to the unincorporated community of Bell Canyon.
Ventura County Waterworks District No. 19	Provides potable retail water service to the Somis area.
Ventura County Waterworks District No. 38	Provides potable retail water service to the Lake Sherwood community.
Ventura Port District	Owns and operates the Ventura Harbor.
Ventura Regional Sanitation District	Owns and operates the Toland Road landfill. Provides support services to various water and wastewater agencies. Authorized to construct and operate sanitary sewer collection and treatment facilities within its boundaries.

Ventura River Water District Provides potable water service via wells to the unincorporated community of Oak View.
