AMENDED JOINT POWERS AGREEMENT DATED , CREATING VENTURA COUNTY AREA HOUSING AUTHORITY

WHEREAS, each party to this Agreement is a public agency authorized to enter into this Agreement; and

WHEREAS, each party hereto has by resolution pursuant to sections 34240.1 and 34241 of the Health and Safety. Code declared that there is a need for a Housing Authority to function within its jurisdiction; and

WHEREAS, there was entered into a Joint Powers Agreement, (the "Agreement") among the County of Ventura, the City of Ojal, the City of Thousand Oaks and the City of Simi Valley, establishing the Ventura County Area Housing Authority pursuant to Sections 34240.1 and 34246 of the California Health and Safety Code, the said Agreement being duly executed by the County of Ventura on December 21, 1971, by the City of Ojai on January 17, 1972, by the City of Thousand Oaks on February 1, 1972, by the City of Simi Valley on February 25, 1972, by the City of Fillmore on April 3, 1973; and by the City of Camarillo on October 15, 1974; and

WHEREAS, the City of Moorpark by resolution declared that there is a need for a Housing Authority to function within its jurisdiction; and

WHEREAS, the powers signatory to the said Agreement lastly executed October 15, 1974, desire that the City of Moorpark be admitted to the Ventura County Area Housing Authority and the City of Moorpark desires such admission;

NOW, THEREFORE, in consideration of the premises and the mutual covenants, promises and agreements herein contained, the parties hereto agree that the said amended agreement recently executed on October 15, 1974, is hereby amended to provide the following:

1. Upon the execution of the within Agreement between the parties, the City of Moorpark shall thereupon be admitted to the Ventura County Area Housing Authority.

2. The Ventura County Area Housing Authority has all of the powers, authority, and duties of a housing authority as provided in the Housing Authority Law, sections 34200 et seq., of the Health and Safety Code, and shall be governed in the exercise of its powers by said provisions of the Healthy and Safety Code.

3. Pursuant to Section 34246 of the Health and Safety Code, the Ventura County Area Housing Authority shall be governed by a board of commissioners consisting of two representatives appointed by each member political subdivision and one commissioner-at-large jointly appointed by all the political subdivision members.

4. The Ventura County Area Housing Authority shall operate on a fiscal year basis beginning on July 1 of each year and continuing until June 30 of the succeeding year.

5. Any incorporated city within the County may join the Authority regardless of whether it has an operating housing authority within its boundaries. Any such city so joining shall adopt a resolution determining the need for a housing authority to operate within its jurisdiction in conformity with sections 34240.1 and 34241 of the Health and Safety Code. The governing body of any such city shall subscribe to an Agreement and be entitled to appoint two commissioners as provided in paragraph 3 hereinabove.

The Ventura County Area Housing Authority may establish such other conditions for entry into this authority as will be fair to the new

members and other members to this Agreement and .ch shall not conflict with the Housing Authority Law.

6. Any party may, at any time prior to the implementation within its territorial boundaries of a housing project as defined in section 34212 of the Health and Safety Code, withdraw from the Authority by resolution of its governing body. Such withdrawal shall not affect any separate obligations of the party to the Authority or to any project of the Authority.

A party may withdraw this Authority subsequent to implementation of a housing project within its territorial boundaries upon consent of a majority of the remaining commissioners and upon approval of the federal or state agency funding the particular project, or otherwise as permitted by law from time to time existing.

7. Any determination concerning the number of housing units to be erected under the direction of sponsorship of the Ventura County Area Housing Authority within the city limits of the City of Moorpark, the type of construction and the density and location of such units, notwithstanding any other provisions in this Agreement, shall be made by the Authority only with the concurrence of the City of Moorpark by resolution of its City Council.

8. This Agreement may be executed in any number of counter parts which together shall constitute the agreement of the parties.
