

JOINT RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF VENTURA AND THE CITY COUNCIL OF THE CITY OF FILLMORE AGREEING TO THE NEGOTIATED EXCHANGE OF PROPERTY TAX REVENUES FOR TRANSFERS OF SERVICE RESPONSIBILITIES AND BOUNDARY CHANGES BETWEEN THE CITY AND THE COUNTY.

WHEREAS, Section 99 of the Revenue and Taxation Code (added by Stats. 1979, ch. 282) requires that prior to the effective date of any jurisdictional change, all agencies whose service area or service responsibilities would be altered by such change shall determine the amount of property tax revenues to be exchanged between and among such affected agencies; and

WHEREAS, it is specified that such jurisdictional change shall become effective only after each affected county and city agrees by resolution to accept a negotiated exchange of property tax revenues; and

WHEREAS, in the event a jurisdictional change affects the service area or service responsibility of one or more special districts, the Board of Supervisors of the county in which such districts are located shall negotiate any exchange of property tax revenues on behalf of the districts; and

WHEREAS, the adopting agencies shall notify the County Auditor who shall adjust the amount of property tax revenue determined for each local agency whose service area or service responsibility would be altered by such jurisdictional change.

NOW, THEREFORE, BE IT RESOLVED:

1. For the territory annexed to the City of Fillmore, effective in the fiscal year commencing after the calendar year of the effective date of the annexation, the County will transfer to the City an amount equal to 13.74% of the County's General Fund share of the 1% property tax, such that the County's share is permanently reduced and the City's share permanently increased for the applicable TRA by this percentage.

2. For the territory annexed to the City of Fillmore, effective in the fiscal year commencing after the calendar year of the effective date of the annexation, the Ventura County Fire Protection District will transfer to the City of Fillmore an amount equal to 100% of the Fire Protection District's share of the 1% property tax, such that the Fire District's share is permanently reduced and the City's share permanently increased for the applicable TRA by this percentage.

3. If there are other jurisdictional changes which occur concurrently with the annexation of territory to the City (such as detachments or annexations to special districts not mentioned in this resolution), there shall be no exchange of property tax revenues in conjunction with those jurisdictional changes.

4. Either party may terminate this agreement as of the 31st day of December of any year upon notice in writing to the other party not less than thirty (30) days prior to the date of such termination.

5. An executed copy of this resolution shall be submitted to the County Auditor-Controller who shall make the appropriate adjustments as provided in subdivision (a) of Section 99 of the Revenue and Taxation Code.

6. An executed copy of this resolution shall be submitted to the Ventura Local Agency Formation Commission.
